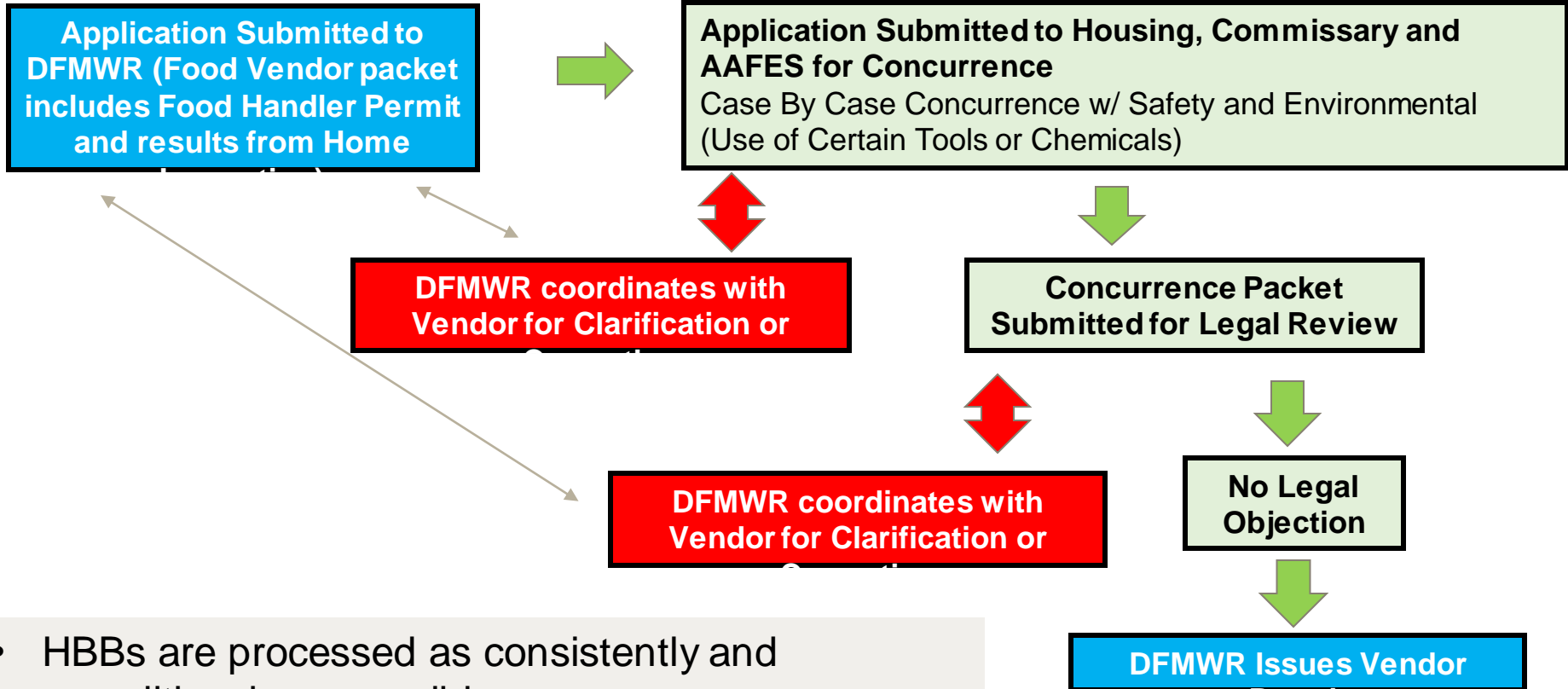

HOME BASED BUSINESS REVIEW AND APPROVAL PROCESS



- HBBs are processed as consistently and expeditiously as possible.
- Regulatory time allocation is less than 60 calendar days.
- Currently processing within 2 weeks from receipt.





HOME BASED BUSINESS REVIEW AND APPROVAL PROCESS

The Directorate of Family and Morale, Welfare and Recreation (DFMWR) is designated as the single point of entry for HBB applications.

- The HBB owner is responsible for:
 - Completing the application paperwork
 - Obtaining the necessary permissions, licenses (if applicable), and liability insurance
- HBB owners residing in privatized on-post housing must obtain approval to operate in writing from the community manager before submitting a request.
- The HBB owner is required to comply with and is subject to inspection by the appropriate city, county, State, or Federal agency, office, or department for compliance with applicable laws, codes, regulations, and requirements.
- The sales or services generated by an HBB generally do not compete with an installation's officially sanctioned commerce. When they appear to compete, the installation will consider HBBs a "supplement" to military exchanges and morale, welfare, and recreation programs or resale activities.

IMPORTANT: Remember you are an official business.

HBBs must pay state and federal **taxes** and follow state and federal requirements.

If you need a sellers permit to sell in California or U.S. then you must obtain that through the state of California or federal government.
