The HBB owner must obtain the requisite permissions, licenses (if applicable), and liability insurance prior to opening/operating. (Request for a waiver of liability insurance must be submitted to DFMWR, and approved by the Garrison Commander)									
The HBB owner is responsible for any damages to third parties arising from the conduct of their business.									
HBB owners providing child care must register with the installation Child, Youth and School Services office as part of the Family Child Care (FCC) provider system.									
The HBB owner is required to comply with and is subject to inspection by the appropriate city, county, state or federal agency, office or department for compliance with applicable laws, codes, regulations and requirements.									
HBB's involved in food preparation and health services may need to be approved by Army Public Health and/or the Local Health Department. The applicant must provide documentation that states the HBB meets all applicable food & health safety and sanitation conditions.									
The residential character of the property shall be maintained. The HBB may not occupy more than 25 percent of the home's gross floor area. Parts or materials related to the HBB shall be screened from public view and will be limited to the interior of the structure or the side and rear yards of the property (no porch pop-ups, etc.). Signage is limited to what can be displayed in a single window from the inside and may not be illuminated. If wanted/needed, obtain an exception to policy (ETP) from The Villages and MWR.									
Customers may only patronize a HBB between the hours of 0900 and 2130. If wanted/needed, obtain an exception to policy (ETP) from The Villages and MWR.									
Noise, vibrations, or odors shall not be detectable beyond the property line.

Pending HBBs can request to buy a single day pass for Special/Community Events.									
All HBB permits are valid for three years. It is recomemended to begin the re-approval process at least 6-7 weeks before it's experation date. If an HBB expereinces a lapse in approval, all pre-approved restrictions will be applied until the renewal process is complete.
